Now to be blunt: 2016 is the year that we make sure all of our Detachment's are abiding by the National Bylaws and the Department Bylaws. Every Detachment has responsibility to file certain paperwork and keep that paperwork up to date. Some of the items on this "Vital Info" List include Annual IRS 990N e-Postcard filing (or similar), maintaining a current Maryland State Incorporation ID # and annually Filing a Maryland State FORM1 tax form. These items are required for you to maintain your status as a Detachment. If steps are not taken to correct deficiencies, you may be in jeopardy of losing your Detachment Charter. You need to start with your local Detachment Paymaster to see what records he/she has.

The 2015 Dept Bylaws that were approved at the last Dept Convention were submitted to the National Judge Advocate for approval last summer. There were a few issues that conflicted with the National Bylaws and he would not sign off on them until they are corrected. We will be discussing those issues at the Dept Winter Meeting. We will published them to the Dept website shortly thereafter. Remember we had 21 changes in 2015 that were good and he had issues with the 2008 Bylaws version.

Keep up the good work, stay visible in your community and continue to bring in new members into our MCL family.

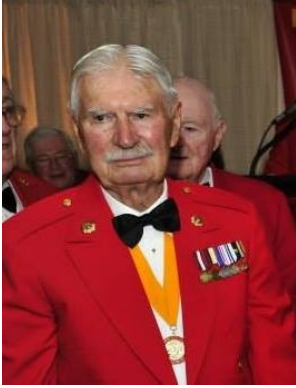

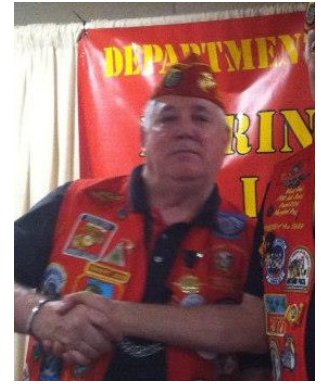

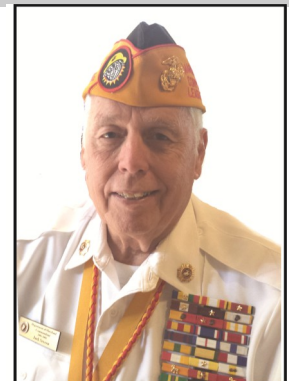

The forms are Fillable PDFs.



Transmittals: (Completed of course), you will need to print five (5) copies Distribution as follows:

Original Signature page and three copies forward to Department, the last copy is for Detachment Records. You must sign all copies, or use carbon paper, you can, but I have not heard those instructions from National. Officer Installation: You will need to print five (5) copies. Four (4) copies forward to Department, the last copy is for Detachment Records.

As above, ditto on additional copies. Death Notice: Same as Officer Installation. I have also been tasked with identifying which Detachments, have or have not filed for an IRS EIN number, or have not filed timely form 990s with the IRS, and have or have not filed Officer Installation forms annually.

All Detachments mail all forms to the Department Paymaster, (Oh yea, more mail for me).

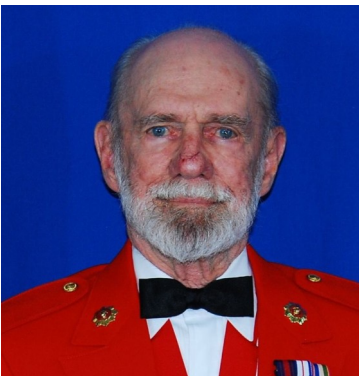
Young Marines East - Bruce Vanden Bos

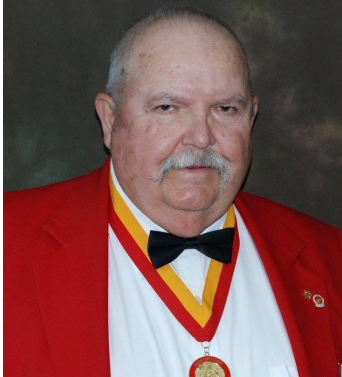
