




Sr. Vice Commandant - Evelyn Remines



While touring such sites (missile runs) at Subic Bay (Olongapo City), Okinawa, South Korea and Taiwan and finally was one of the first Marines of VMFA 115 in March of 1972 to go from Okinawa to Viet Nam. While doing that run I was on a crew that worked for 56 hours straight going from Okinawa and then staying on at night in Viet Nam to get the F4B Phantoms up and running on their very first day at Viet Nam. While with VMFA 115 I was promoted to Sergeant and finally got mustered out in February 1973.

I'm currently assigned to Elaine, my CO since 1986. Besides the Marine Corps League and MODD I've also been a Commander for both the VFW and American Legion Posts. Another favorite military organization that I'm very proud to be a member of is the Military Order of the Cootie. I'm a Past Grand of Maryland Seam Squirrel, Grand Quartermaster, 4th Supreme District Treasurer/Adjutant and Tomb Trek Treasurer. 
