#### **2018 TOYS FOR TOTS PROGRAM**

The 2018 Toys for Tots Program was extremely successful. Attached is the information submitted by the Detachments and no additional information was submitted prior to printing this report. Hopefully, in the future, Coordinators will submit information on any time of participation they have with their Detachment, County or an organization who supports the Toys for Tots Program. It will be helpful if the Commandant or Coordinator supply that information prior to the October 1<sup>st</sup> kick off date of the Toys for Tots Program.

#### VAVS COMMITTEE

During this period, volunteers were informed that in order to protect the health and well-being of Veteran patients, the flu vaccination is now required for all volunteers and employees throughout the VA health care system nationwide. A volunteer who chooses not to receive the flu vaccination may take a break and return to volunteering after the flu season or they <u>must wear a mask</u> while volunteering at any VAMHCS facility during the flu season (December 1, 2018 through March 31, 2019).

The design for the new hospice facility at Loch Raven is ongoing and the facility will be accessible from the main portion of the building. Volunteers are always needed and recertification classes will be scheduled during the next months. The new clinic is located at 5253 King Avenue, Rosedale, Maryland; an open house which afforded patients and volunteers the ability to see the layout of the facility prior to its opening.

Currently, donations are being requested at Loch Raven so that new televisions may be purchased for each living facility in the hospital. Also, there is always a need for funds for the VA homeless facility, coffee fund and general fund, just to name a few. It is also time for the Golden Age Games and funds are being solicited so that our athletics can be sent to the games. A copy of the first Annual Joint Review for Loch Raven is attached. We hope that during this year, we can increase our volunteer participation and have Department members participate in other types of events held at the facility, i.e. cookout and/or Bingo.

- Charlotte Hall Veterans Home is a program under the Maryland State Department of Veterans Affairs-George W. Owings, III, was appointed by Governor Hogan to serve as Secretary in February 2015
- Opened in 1985- Celebrating 34 years of "Serving Those Who Served"
- US Dept. of Veterans Affairs funding through a grant program called "State Veteran Home and Construction Grant Program" 65% US Dept. of Veterans Affairs funding- 35% State of Maryland Funding
- 286 Skilled Nursing Beds + 168 Assisted Living Beds =454 total beds
- Room Rates: Assisted Living \$177.00-\$180.00 per day, Skilled Nursing Facility \$286.00-\$290.00 per day depends on private room, semi-private room or memory care room
- Number of Rooms: AL # 30 single & 100 double, SNF # 86 single, & 100 double rooms
- 2018 Average Occupancy: 89%
- March 1- March 31, 2019: 13 Admissions, 1 Discharges, 10 expired=(2 net from February)
- 34% of population are between the ages of 80-89
- Population includes 15 female veterans & 30 female spouses
- 82% of veteran population served during war time
- 48% of veteran population served in the U.S. Army
- Distinguished Medal Recipients:

- On-Site Barber and Beauty Shop, Massage Therapy/Pain Management Practitioner
- On-Site Veterans Service Officer- Certified by US Dept. of Veterans Affairs
- Robust Volunteer Program- Over 22,000 hours recorded last year
- More affordable- current USDVA Per Diem Rates:
  - \$109.73 per day for Nursing Home Care=\$3,291.90 per month savings
  - \$47.36 per day for Assistant Living Care=\$1,420.80 per month savings
  - A VP1- 70% or greater Service Connected Veteran may be entitled to the full cost of nursing home care.

In the Baltimore district tables, I have indicated the County. To find the part of the county for the district, you can look at the council map for the districts.

There are Councils made up of Districts with units, in this case troops. I did a search for Councils in the state of Maryland. The attachment labeled Maryland Councils give you the information for our state. If you want a different state, use the following URL

www.scouting.org/discover/local-council-locator It will ask you for a zip code. Put a town/city in the area you are interested. I looked up zip codes for Frederick, Hagarstown, Cumberland and Oakland to get information. The information the National scouting website will give you is the name of the council, the address of the headquarters, and the major phone number. If you google the council name, you can get the URL for their website.

When you visit the Council website, you can find the names of the districts and contacts for them. I made up a table for the Districts in Baltimore Area Council to give you the idea. The District Executive/Director is the paid person who works for the Council and with the District. He/she can answer your questions. The district website will give you information on the makeup of the District. The District Chair is in change of most of the District functions and knows a lot about advancement. The advancement chair works with the eagle applications. The District Commissioner works with the units and runs the Roundtables (monthly meetings of scout leaders).

Each troop maintains a list of what organizations they contact for certificates to be given to the eagle for the Eagle Court of Honor. This list is modified for each Eagle. There is no mandatory list that every unit uses. To get on that eagle's list, you either make an announcement at Boy Scout Roundtable (contact the District Commissioner for the date, time, and place) to let unit leaders know or make a presentation at that Roundtable. The other way to get on a list, is to contact the District advancement chair and see if your organization can be added to the list that they distribute at the Eagle Information training that is given to life scouts who are working toward eagle. As far as I know there is no master list of boys who are in the eagle process. Each district has their own process. The District Advancement committee is aware of which eagle candidates have gotten permission for their project and later when they turn in their notebooks for an Eagle Board of Review. My guess is that both lists are not available to the public for privacy concerns.

For scholarships, the Roundtable and Life to Eagle information meetings are the best way. For certificates, the same is true. For information about possible Eagle projects, I think that the best bet is to contact the District Advancement Committee. They may suggest a visit to Roundtable.


