We must report great news! Our Woodford Reserve Bourbon Raffle went very well. I am pleased to pass along that We raised \$935 for American's Vet Dogs.

As much as I hate to mention this I am compelled to do so; no one, other than Law enforcement may bring a firearm into an American Legion post. This fact is found in their Department By-Laws. But here is the problem. There is no mechanism to prevent a weapon from being brought into the post. Given that on 28 July a man was videoed walking down the New York City Streets was a loaded non-NY compliant AR-15 rifle. This man later murdered 4 people and then himself. A week later 3 soldiers were shot by a fellow soldier at Ft Stewart Ga. We need to keep our heads on a swivel and observe our surroundings. If it doesn't look right it ain't. A word of caution, even in Cumberland, Md the response time for an active shooter is at a minimum 3:00 minutes.

This is a bit of a milestone for me, 15 November will mark the 8th time that I have proudly served as the Master of Ceremonies for a Marine Corps Birthday Party. This year's party will be the largest that I have served in this capacity. Our guest speaker is a NATIONAL Officer.

During the past quarter I have met with both Antietam #113 and Garrett County #1234. Both Detachments are very active and well lead. Both detachments are actively recruiting new members. But more importantly, they keep their members actively involved.

From my own experience, I am certain that that both Marines and Associates join a detachment for two primary reasons. The first reason is fellowship with other like-minded individuals. The second is to be part of an organization that actually works for the benefit of our communities and veterans.



MVC Quarterly Meeting

On Tuesday 15 July 2025 the Maryland Veterans Commission held the Summer quarterly meeting at 100 Community Place, Crownsville, MD. in person and by phone with 24 Commissioners representing VSOs and congressional districts, representing the Marine Corps League was Commissioner Stuart Blair, PDC and Bernadine Blair MCLA PP.

Introduction of Mike Bowers, Chairman, Maryland Veterans Commission

Acting Secretary Ross Cohen for his presentation: Deputy Secretary Cohen –

 update on the Department and then call on Rory Nolan, who serves as Chief of Staff to Delegate Heather Bagnall for an update on the Maryland Military Women's Memorial and next Heather Geraldes, Executive Director of the Trust for an update on the Maryland Veterans Trust Fund.

Service Benefits Program

- In FY 2025 DVMF filed 5,667 claims for Veterans, Dependents & Survivors
- Monetary benefits awarded to Maryland Veterans & family members = \$54,445,746
- These are record breaking numbers in both categories
- The approval rate of claims filed in FY 2025 = 94%

 We have plans to open two new benefits offices at MVA's in Annapolis and Waldorf. No exact date on the openings yet, but we will let you know.

Cemetery & Memorials Program

- Pre-applications have increased for 2025
- Interments for Veterans and Dependents also increased slightly for 2025
- Maryland is home to 1.5% of Veterans in the United States, but we interred 7% of Veterans and family members, when compared to state cemeteries across the nation making Maryland the most active state cemetery program in the US.
- o The increased activity has led to some brief delays in scheduling interments -
- Up to 21 days at Cheltenham, Garrison Forest & Crownsville
- Two weeks at Rocky Gap and Eastern Shore
- Unaccompanied Veterans Ceremonies will be held on July 25th at three of the Cemetery locations:
- Crownsville
- o Garrison Forest
- Rocky Gap
- The information on the ceremonies and the names of the Veterans were included in last Friday's edition of the newsletter. Denise can send the information to you, if you missed it.
- The Eastern Shore cemetery will observe the 50th anniversary of being established in 2026.

Charlotte Hall Veterans Home

- Census has been increasing gradually since the Pandemic.
- 2024 Average Occupancy was 57%.
- Average daily census is 272, and currently we have 276 residents.
- 43% of the population is between the ages of 70-79 the largest age bracket for residents.
- Population includes 13 female Veterans & 30 female spouses.
- 96% of the veteran population served during wartime.
- HVAC system has been replaced in all common areas of the home.
- A new Chair has been elected by the Maryland Home Commission, Ken Streicher.

Communications, Outreach & Advocacy

- During the month of June, Roslyn Jones, Women Veteran/Inclusion Program Manager organized two successful events to recognize Women Veterans and celebrate Women Veterans Recognition Day.
- The first was held at American Legion Post 136 in Greenbelt. Special thanks to Commission Vice Chairman Mike Moore for his support of the event.

- Dignitaries attending included Maryland National Guard Adjutant General Janee
 Birckhead and Jacquelyn Hayes-Byrd Executive Director of the USVA Center for
 Women Veterans.
- The second event held for Women Veteran Entrepreneurs at Morgan State University, also included staff from the Governor's Office on Small, Minority and Women Business Affairs.
- Maryland Joins Forces, has grown to over 30 partner organizations and in September will host service projects as part of a Building Community Through Service campaign. If the VSO you belong to would like to partner on these service projects, please contact Lindsay Livingston or Deputy Secretary Dana Burl.
- On August 8th, DVMF will co-host a Mission Strong Summit in partnership with Joint Base Andrews. The first summit of this kind was held at Ft. Meade. These summits bring together community organizations and military service providers to discuss ways to strengthen partnership and problem solve challenges facing our military connected community.
- We have been updating you on plans to redesign and update the DVMF website. That
 work has been going on behind the scenes for nearly two years. The design phase is
 finished and we are now checking content. We will soon be ready to launch the new
 website.

Acting Secretary Cohen called on Rory Nolan from Delegate Bagnall's office for a report on the Women's Memorial:

- The Commission made three recommendations for location
- Place it at the museum/Patriot Place in Charles County
- Place it in Sykesville at the new Veterans Home location
- o Place it in Havre de Grace
- There is not a formal process in state government to make a decision on the location options
- Funding options are needed for three phases
- Design process
- Build process
- Maintenance process Note the Maryland Historical Trust does maintain some monuments in the state
- Patriot Point would be difficult for the state to maintain because it is on private property. A non-profit would have to be established to handle the design process. Capital funding could then be requested from the state
- Sykesville location would provide state accountability throughout the process. DVMF would have to agree to that location, and the grading of the property may be an issue.
- Patriot Point is a more straight-forward path, not as dependent on state funding. Who would be responsible for establishing a 501c3?
- There is no formal process defined by the state, so we could make one up

The Acting Secretary called on Heather Geraldes for her presentation on the current status of the Trust Fund.

Presentation:

Grace Caulfield to present on Easterseals/the Steven A. Cohen Clinic Grace discussed the programs serving Active duty Service members and military connected families.

Commissioners round robin "Responsibilities of Commissioners".

Chairman Bowers called for a Motion to adjourn. Meeting was adjourned at 1:32 pm.




